# *Amendments on the Ballot*

## **Amendment 1, Partisan School Board Elections Amendment**

Proposing amendments to the State Constitution to require members of a district school board to be elected in a partisan election rather than a nonpartisan election and to specify that the amendment only applies to elections held on or after the November 2026 general election. However, partisan primary elections may occur before the 2026 general election for purposes of nominating political party candidates to that office for placement on the 2026 general election ballot.

## **Amendment 2, Right to Hunt and Fish Amendment**

Proposing an amendment to the State Constitution to preserve forever fishing and hunting, including by the use of traditional methods, as a public right and preferred means of responsibly managing and controlling fish and wildlife. Specifies that the amendment does not limit the authority granted to the Fish and Wildlife Conservation Commission under Section 9 of Article IV of the State Constitution.

## **Amendment 3, Marijuana Legalization Initiative**

Proposing an amendment to allow Adult Personal Use of Marijuana.

## **Amendment 4, Right to Abortion Initiative**

Proposing an amendment to Limit Government Interference with Abortion.

## **Amendment 5, Annual Inflation Adjustment for Homestead Property Tax Exemption Value Amendment**

Proposing an amendment to the State Constitution to require an annual adjustment for inflation to the value of current or future homestead exemptions that apply solely to levies other than school district levies and for which every person who has legal or equitable title to real estate and maintains thereon the permanent residence of the owner, or another person legally or naturally dependent upon the owner is eligible.

## **Amendment 6, Repeal of Public Financing for Statewide Campaigns Amendment**
