Prestaging Directions on the NEXT Page

All drivers must present proof of attendance at the line-up.

Theme: Units must be substantially decorated with lights.
ONLY Christmas music (religious, secular, or popular) is allowed.

NO Santa Claus (other than decorations) Allowed

(Santa will be on the last fire truck ONLY)

Route: Page 5

Disbanding: The parade ends at Elva & Stewart Streets.

Entries may turn left or right to the pre-selected, post-parade meeting area.

Please notify buses/parents of this location so they can meet you.

Judging: The unit must be identified for judges.

DO NOT STOP TO PERFORM.

Entries that stop to perform cause gaps and safety hazards
for floats following during the parade.

MWI can only allow future entry into the Milton Christmas Parade if your group stops.

Judges will be near the intersection of Stewart St. and Berryhill Road.

***Safety: All floats must have a MINIMUM of 2 safety walkers
who are 21 YEARS OF AGE OR OLDER. One of each side of the float!
They are a guide to keep children and guests safe during the parade.
Make sure they understand their role as safety walkers!***

All Public Safety Units, Law Enforcement, Fire Departments, and
Emergency Management should be pre-registered for the Parade!

Enter off Dogwood to Sanders Street.

and want to be together.*

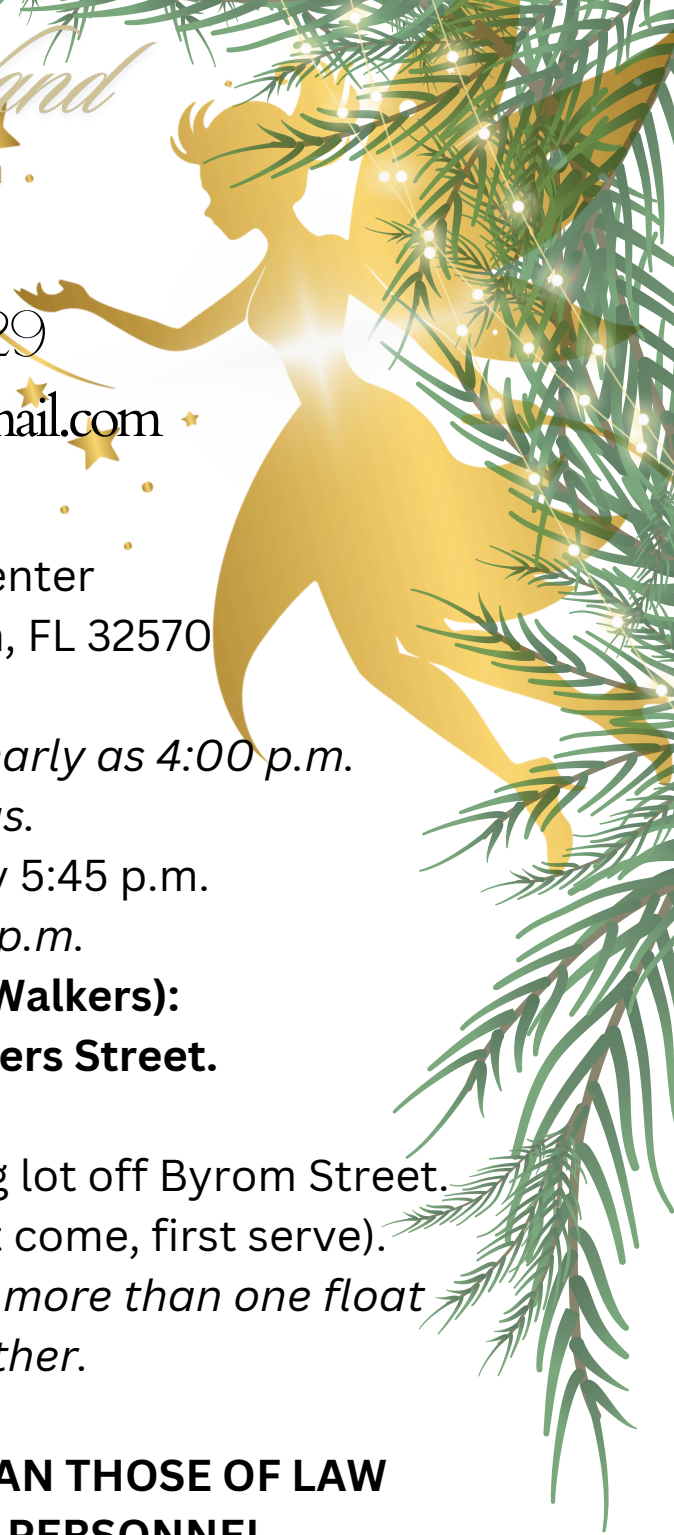
**NO ANIMALS ALLOWED OTHER THAN THOSE OF LAW

or towed/ticketed vehicles or personal property.

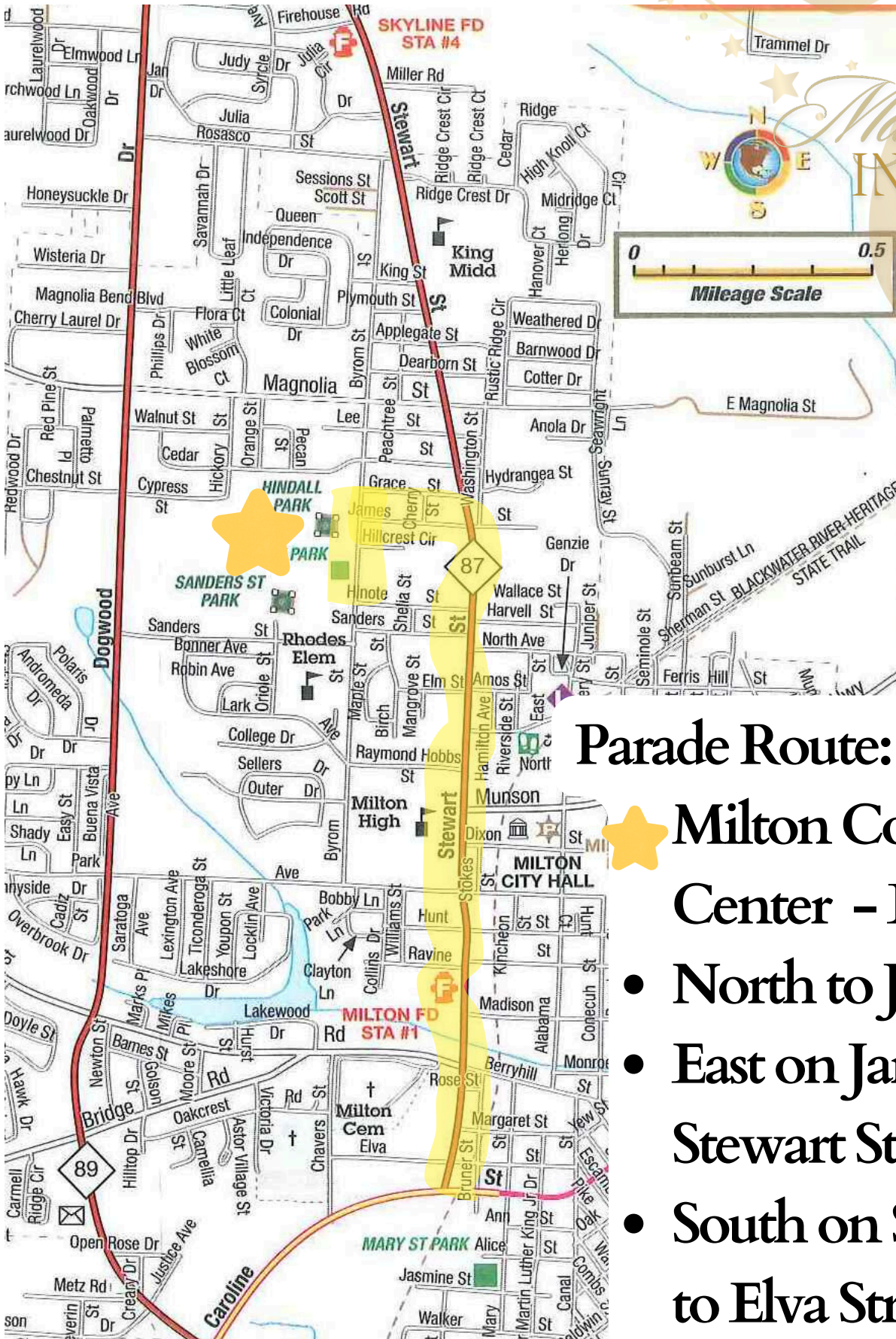
